Material Preparation

- 1. Fill the required quantity of clean water (approx. 2.5 2.6 liters) into the bucket up to the mark.
- 2. Add binder concentrate and mix thoroughly with the water in the bucket (min.30 sec).
- 3. Add the bag of light filler and mix to a creamy mixture.

Note: Detailed instructions for preparing material in the bucket.

Application

- 1. Apply BASWA Prime with the stainless steel 3x3 mm (BASWA Basic system 4x4 mm notched trowel also possible) or 6x6 mm (BASWA DTG system) notched trowel over the entire surface of the already glued and flat sanded surface and smoothen it to a flat, even surface. (Size of the notched trowel depends on substrate and installation situation)
- 2. After sufficient and complete drying, sand the surface flat. (Observe drying time and room conditions → min.24 hours / mm layer thickness)
- 3. Subsequently coat the surface, which has been ground flat, with BASWA acoustic plaster (BASWA Base / Fine / Top / Casual) in accordance with the latest BASWA application guidelines.
